



SB 823 2021-2022 Local Plan Addendum

Introduction

The Office of Youth and Community Restoration (OYCR) requested an addendum containing disaggregated demographics, offense data, and specific dispositions of Riverside County Probation (RCP) youth with 707(b) of the Welfare and Institutions Code (WIC) and 290.008 Penal Code (PC) offenses, for 2019, 2020, and 2021. Also included is information pertaining to RCP's housing classification for secure track youth.

Demographics, Dispositions, and Offenses for 2019-2021

Classification of Youth

When a youth is committed to the Pathways to Success program, relevant characteristics such as age, developmental maturity, mental and emotional health, sexual orientation, gender identity and expression, disabilities, and/or special needs will be taken into consideration for classification of appropriate housing, safety, and well-being of the youth. To suitably house youth, according to classification, two male living units will be dedicated for this purpose. RCP will also be able to provide secure track programming to female youth. The living units will be distinguished between age, maturity level, high school, and college/higher education. Depending on the severity of the needs of the youth, RCP along with the treatment team will determine which living unit is most appropriate.
