## **Director's Letter**

As we kick off the new year, we reflect on the progress OYCR has made in our work to transform California's youth justice system.

In 2023, we entered a new era of county-based care for all youth in the juvenile justice system. By providing technical assistance, resources, training, policy leadership, and highlighting best practices, OYCR has been honored to serve as a partner for counties and communities as they develop the necessary programs and infrastructure to care for our youth. We completed our visits to every secure youth treatment facility in the state which included meeting with leadership from every county probation department, and we also met with various youth-serving statewide and local community-based organizations (CBOs).

As we move forward, we will continue building bridges and establishing strong partnerships across the youth justice system which includes behavioral health, educators, vocational partners, social workers, treatment providers, youth advocates, judges, defenders, and district attorneys as well as probation officers.

Last year, we also provided monumental funding to increase CBO capacity and empower communities to care for youth, including the launch of a <u>\$3 million</u> project to provide grants and technical assistance to CBOs. We know from our field experience, juvenile justice research, brain science, and data that longer youth incarceration times **do not** equate to better public safety outcomes. That's why OYCR is committed to investing in the development and expansion of community infrastructure to ensure youth transition into Less Restrictive Programs as soon as their individualized treatment plans are fulfilled, and their treatment teams recommend it. We are energized as we continue our work of creating a more equitable California and making sure our most vulnerable youth grow up to be healthy, successful adults through restorative justice and positive youth development models.

# **2023 Highlights**

## **Ending Girls' Incarceration**

OYCR partnered with the Vera Institute of Justice to launch <u>the Ending Girls'</u> <u>Incarceration</u> Action Network, a 4-county pilot project that aims to zero out the incarceration of girls and gender-expansive youth. Since the program launched in April, Los Angeles, San Diego, Imperial, and Sacramento counties have been developing gender-responsive programming and working toward ultimately ending the incarceration of girls and gender expansive youth who do not pose a risk to public safety.

## Youth Bill of Rights

In collaboration with youth, probation officers, child welfare organizations, and other stakeholders, OYCR developed standardized materials presenting the Youth Bill of Rights in age-appropriate language. They are currently available on our <u>website</u> in English and Spanish, and will be mailed out to counties in the coming weeks. #### **Rising Scholars**

Through AB 417, California community colleges have received more than <u>\$15</u> million to support higher education opportunities for youth in detention settings and increase the number of justice-involved students participating and succeeding in community colleges. Research shows that postsecondary education is the most effective pathway to reduce recidivism and increase employment.

#### **Less Restrictive Program Grants**

OYCR is awarding grants to county probation departments and community partners to fund innovative approaches to transitioning youth from Secure Youth Treatment Facilities to less restrictive programs as soon as it is deemed appropriate by the youth's care team and the court. Funds are awarded in the range of \$100,000 – \$200,000 per youth to provide 24 months of support and strategically targeted services.

#### **Data Partnerships**



# California Awards \$150 Million to Support Mental Health Programs for Youth and Young Adults

As part of Governor Gavin Newsom's <u>Master Plan for Kids' Mental Health</u>, The Department of Health Care Services (DHCS) awarded \$150 million in grants to 262 organizations to support the mental health and wellness of children, youth, and young adults. California also <u>introduced</u> the Certified Wellness Coach program and <u>website</u> to support overall physical, emotional, and mental wellbeing, and build a more diverse behavioral health workforce to help children and youth. <u>Read the Governor's press release</u>.

In a massive victory for youth and education, the <u>Underground Scholars</u> program at UC Riverside received a \$300,000 grant from the <u>California Wellness</u> <u>Foundation</u> to help youth who are court-involved succeed in college.
