Introduction

This document is to supplement the JJRBG Data Collection Form to outline data reporting and provide definitions for each variable. Using the data collection form will meet all the data reporting requirements for the Juvenile Justice Realignment Block Grant (JJRBG) county plan.

The data covered by the template is outlined in Welf. & Inst. Code § 1995(D)(1):

- (1) A description of the realignment target population in the county that is to be supported or served by allocations from the block grant program, including the numbers of youth served, disaggregated by factors including their ages, offense and offense histories, gender, race or ethnicity, and other characteristics, and by the programs, placements, or facilities to which they are referred.

OYCR welcomes any additional data and any data analyses or presentation that your department has prepared. However, providing the data in the data template will be sufficient to meet the requirements for the JJRBG county plan.
