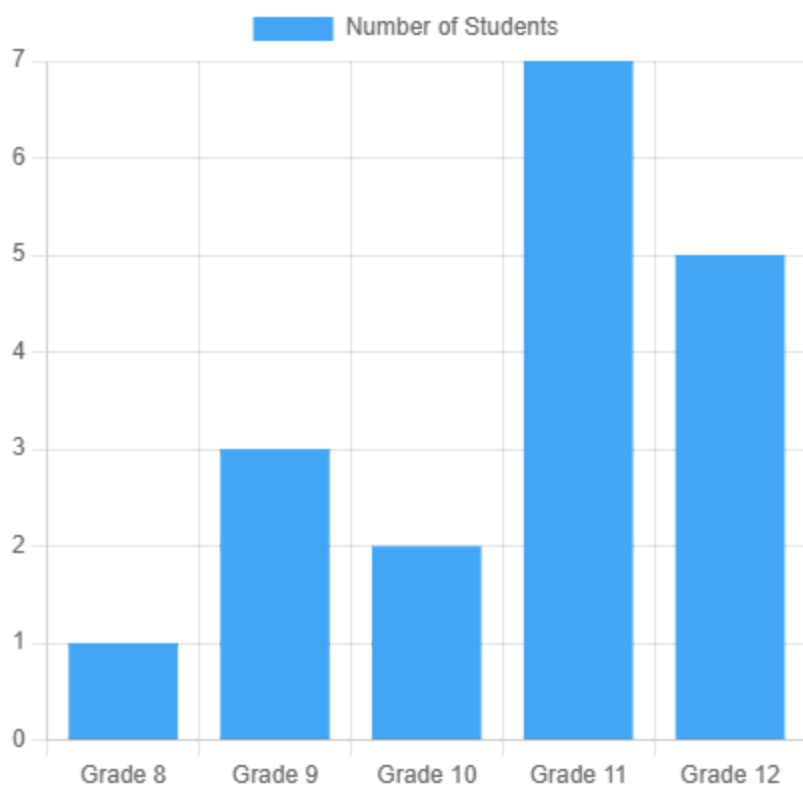

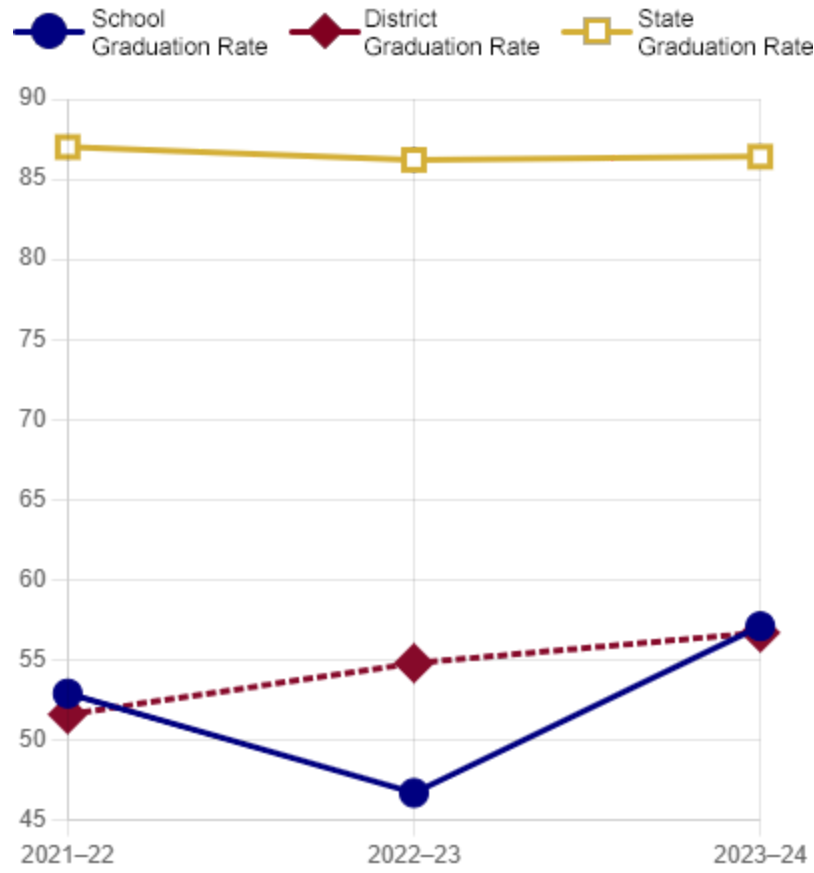

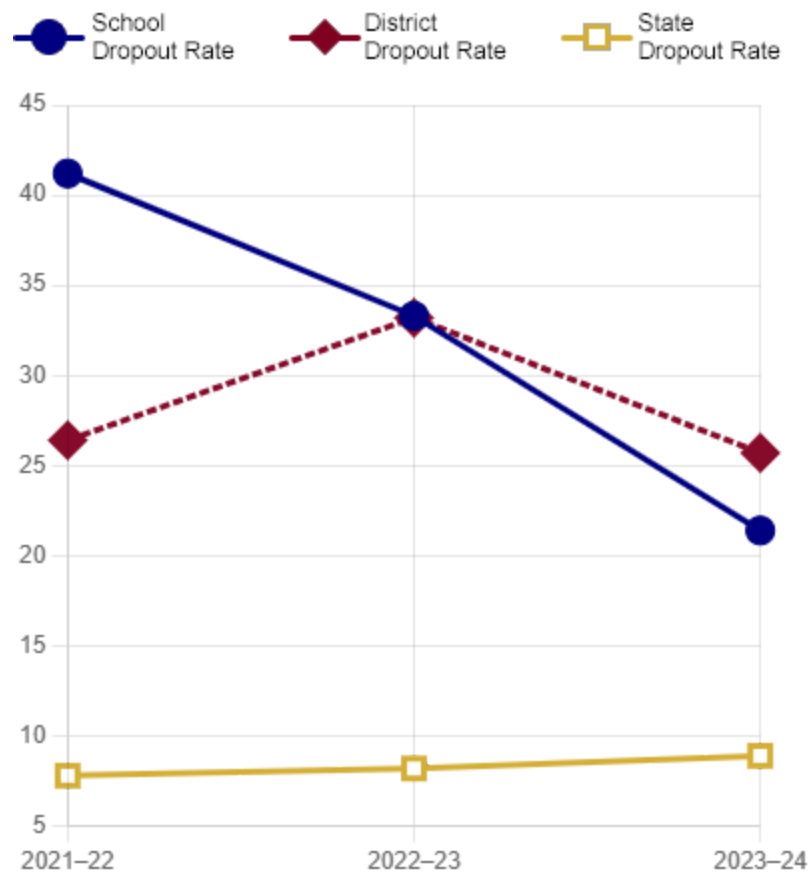

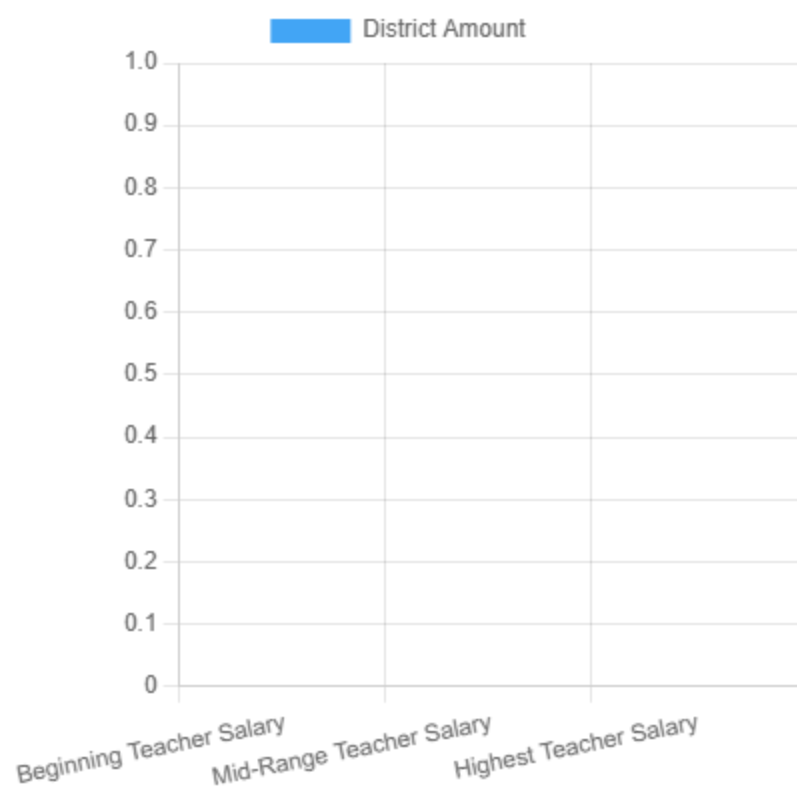
Types of Services Funded (Fiscal Year 2023–24)
