Co-Chair Davis asked to confirm whether youth were able to contact their visitors. a. Darius clarified that this depends on the policy of the facility due to the lack of existing law. ii. AB 1659 (Ransom) iii. AB 1886 (Elhawary) 1. Darius provided an overview of AB 1376 to provide background on this bill. 2. Co-Chair Davis asked what the process is under AB 1376 when a youth hits the one-year mark. a. Darius clarified that a probation department must submit a request to extend probation, and a juvenile court must determine whether it is more likely than not to be in the best interest of the youth and public safety to extend probation. iv.
